THIRD AMENDMENT TO AMENDED AND RESTATED DECLARATION OF COVENANTS, CONDITIONS, AND RESTRICTIONS FOR THE THUNDER SPRING DEVELOPMENT, A CONDOMINIUM

The following provision shall be added to and supplement the AMENDED AND RESTATED DECLARATION OF COVENANTS, CONDITIONS, AND RESTRICTIONS FOR THE THUNDER SPRING DEVELOPMENT, A CONDOMINIUM ("Declaration"), recorded as Instrument no. 554269 on December 24, 2007, as follows:

1. New Article: Article 22. CONDUCT

A new Article 22 shall be and is hereby added to the Declaration with the following provision:

ARTICLE 22. CONDUCT

Section 22.1

Owners and their guests and tenants shall not engage in any abusive, harassing, or offensive behavior or conduct, either verbal or physical, or any form of aggression, threat, or intimidation directed at other Owners, residents, guests, occupants, invitees, or directed at management, its agents, its employees, or its vendors.

2. Survival of Remaining Terms of Declaration. Except as amended herein, the Declaration and all of its terms and provisions remain in full force and effect.

- 3. **Conflict**. In the event of any conflict among this Amendment, the Declaration, Bylaws, Articles of Incorporation, or Rules and Regulations, this Amendment shall prevail. To the extent not modified by this Amendment, all of the provisions of the Declaration, Bylaws, Articles of Incorporation, and Rules and Regulations are hereby ratified.
- 4. **Effective Date.** This Amendment shall be effective as of the date of recording in Blaine County, Idaho.
